Seminar classes

After learning the concept of national interest, as well as exploring the “system” in the international system, we will focus on power as one of the key and contestable categories in the theories of international relations. Briefly considering diversity of theory, its contested nature, the foundation of the discipline of International Relations, the Behavioral Approach, the Structural Approach, and the Evolutionary Approach, we aim to thoroughly examine major theories of international relations: realism and neo-/structural realism, liberalism and neoliberalism, constructivism, Marxism, as well as feminist perspectives. The English School, critical theory, postmodernism, and Green politics will also be covered.

Please, take into consideration that the schedule is tentative and its change is at the instructor’s discretion.
